assignment is a three-page paper. There is a textbook, but we find no reading assignments in the syllabus.

The applicant did not do enough to show that the course has a focus on history. There were no weekly topics or discussion of the assignments. Only a sentence in the Course overview seemed related to history but there was no more detail. The first section of the course did not even mention the past. On an administrative note, it did not include the Table of Contents of No Pity, which seems critical to the instructor's application and it did not separate criteria 3 and 4.
