Rationale: The committee would like more information about the critical evaluation that would merit "L" designation. Although the course seems to meet the spirit of the "L" designation, there is not enough information in the syllabus to accurately assess the depth and quality of the written reports turned in for the units or the final project. Expectations for content, quantity, and quality need to be shared with a rubric and narrative description of each assignment.

HEB 314 Advanced Modern Hebrew

Rationale: The committee would like more information about the critical evaluation that would merit "L" designation. Although the course seems to meet the spirit of the "L" designation, there is not enough information in the syllabus to accurately assess the depth and quality of the written reports turned in for the units or the final project. Expectations for content, quantity, and quality need to be shared with a rubric and narrative description of each assignment.

OGL 200 Introduction to Organizational Leadership

Rationale: Although the course seems to meet the spirit of the L designation, there is not

enough information in the syllabus to accurately assess the depth and quality of the required papers. Expectations for content, quantity, and quality need to be shared with a rubric or other mode of explaining expectations for excellence to accurately determine if training in literacy and critical inquiry is sustained. Additionally, the course objectives could more strongly reflect a focus on literacy and critical inquiry.

REL 347 Religions of India

Rationale: Although the course seems to meet the spirit of the L designation, there is not enough information in the syllabus to accurately assess the depth and quality of the required papers. Expectations for content, quantity, and quality need to be shared with a rubric or other mode of explaining expectations for excellence to accurately determine if training in literacy and critical inquiry is sustained. Some of the writing assignments do not, as described, appear to meet the requirements for "L" designation (e.g. midterm exam, and 1½-2 page proposal comprised of an abstract and bibliography).
