## Revise and Resubmit or Deny for L designation (mandatory review):

AES 301 Air Force Leadership Studies I (Mandatory Review)—Deny

**Rationale:** The writing assignments do not involve sufficient critical inquiry—the gathering, interpretation, and evaluation of evidence—nor are they substantial writing tasks. A one page paper for each assignment does not meet the spirit of an L designated course. For example, writing a memorandum or a personal letter is not equivalent to writing a critical analysis.

AES 303 Air force Leadership Studies II (Mandatory Review)—Deny

**Rationale**: The writing assignments do not involve sufficient critical inquiry—the gathering, interpretation, and evaluation of evidence—nor are they substantial writing tasks. A one page paper for each assignment does not meet the spirit of an L designated course.

AES 401 National Security Affairs (Mandatory Review)—Deny

**Rationale:** The literacy and critical inquiry elements are not sufficient for "L" designation. For example, class participation does not warrant "L" designation, nor does an impromptu speech. A background paper simply reports facts, but does not engage the student in critical inquiry.

## B) Mathematical Studies (MA)/(CS) (Brian Skromme) From ASU:

### **Revise and Resubmit for CS designation (mandatory review):**

CIS 105 Computer Applications and Information Technology (mandatory review)

Rationale: This course is a very broad introduction to computers and applications of IT in business. It is not clear however from information provided that it has significant content in quantitative analysis, modeling, simulation, animation, or statistics, and in particular that there is enough content in spreadsheet analysis, systems analysis and design, and decision support systems, or in modeling or statistics studies. The final exam does not appear to cover these topics in detail, and there is no description of what sort of assignments students are actually required to complete. The use of spreadsheets appears fairly basic and may not really extend to decision analysis or modeling in a substantial way. The emphasis seems to be more on how to construct basic spreadsheet formulas and perform database queries than on applications to real problems.

CIS 236 Honors Introduction to Information Systems (mandatory review)

Rationale: Comments similar to those for CIS 105 above. Course seems more focused on methods to select software packages for business applications than on actually learning to use software for modeling, decision support, etc. Insufficient evidence or details of assignments that require students to use software for purposes that would meet CS criteria.

Rather than teaching literary analysis the course appears to be a practical training course for teachers -- therefore, we have voted to deny the proposal.

## **Revise and Resubmit for G designation(mandatory review):**

GCU 425 Geography of the Mexican American Borderland (Mandatory Review) **Rationale:** The content of the course is both of the U.S. and Mexico. The criterion 2.c calls for more than half of the content to be non-U.S. based. The committee requires more information to determine the degree of content that is global. More information is requested about the nature of the assignments and use of the readings, which, in some cases, suggest a greater emphasis on the U. S. border experience.

## **Denied for G designation (mandatory review):**

ASB/WST/SSH 400 Poverty, Social Justice, and Global Health (Mandatory Review) **Rationale:** The emphasis is placed on social justice and ethical issues related to health. Relatively few of the lessons within the modules in the course deal with global health and awareness. The course does not meet criterion 2c.

## **Revise and Resubmit for H designation(mandatory review):**

APH 313 History of Architecture I (Mandatory Review)

Rationale: The instructor did not explain how the course meets the criteria.

Chronological organization is not sufficient. There needs to be more details about how the course meets the criteria. For example, how do assigned readings address criteria 2, "Explains human development as a sequence of events"? No narrative description of how course meets criteria—just referrals to examples in syllabus. General Course Description and Instructional Objectives include useful narrative information, but it's not clear from the weekly topics and assignments how these objectives are realized in the course.

ASB 337 Pre-Hispanic Civilization of Middle America (Mandatory Review)

**Rationale:** Please type. Criteria 3 and 4 need to be addressed separately. Needs to be more specific in addressing how each Criterion is met. Lacks table of contents for textbook.

APH 314 History of Architecture II (Mandatory Review)

Rationale: Revise and resubmit: The instructor did not explain how the course meets the criteria. Chronological organization is not sufficient. There needs to be more details about how the course meets the criteria. For example, how do assigned readings address criteria 2, "Explains human development as a sequence of events"? No narrative description of how course meets criteria—just referrals to examples in syllabus. General Course Description and Instructional Objectives include useful narrative information, but it's not clear from the weekly topics and assignments how these objectives are realized in the course.

ARS 201 Art of Asia (Mandatory Review)

**Rationale:** The instructor does not explain how the course teaches that human development is a sequence of events. (Criteria 2) or how human institutions change over time (Criteria 3). Not well demonstrated that it's not just the history of a field of study. Course appears to be only in chronological order.

## **Denied for H designation (mandatory review):**

ARS 465 Native Art of North America (Mandatory Review)

**Rationale:** The instructor does not make clear how history is a part of the class. It is not apparent that the course delves deeply into history or the past. Focus seems to be on the present-day and not change over time.

ARS 466 Native American Art of the Southwest (Mandatory Review)

**Rationale:** The instructor does not make clear how history is a part of the class. It is not apparent that the course delves deeply into history or the past. Focus seems to be on the present-day and not change over time.

HCR 220 Introduction to Nursing and Healthcare Systems (Mandatory Review)

Rationale: History does not appear to be a focus of the course. History of a field of study is not permitted. Amount of time and reading dedicated to the history of each field is insufficient. Textbook does not address history.

Criteria need to be addressed separately.
