JPN 115: Japanese Popular Culture

Rationale: The application argues that the course should qualify for the HU designation, but the syllabus falls short. Criteria 4a is a concern as religious thought is minimal in the course. Moreover, the allowance for the student to use his/her own cultural references in their papers (which is the primary indication of analysis) seems to me to detract from the Humanities components seminal to meeting the standards for the designation.

Revise & Resubmit: (new) From MCCCD

HIS 203 African American History to 1865

Rationale: A case could be made for this course to receive HUM designation, but not in its current iteration. The author's explanation for criteria 1 fails to link the course to the criteria. It speaks of the historical elements of the course, but neglects to discuss the "...development of philosophies, religions, ethics or belief systems, and/or aesthetic experience." This course fits the criteria for the H designation. For these reasons, I reject the application for a HU designation.

MHL 153 Rock Music and Culture

Rationale: The assignments included address only relatively superficial aspects of history (the chapter questions) or focus on aesthetic experience and other HU-related topics. The headings of the textbook chapters provide few clues about the extent to which the requirements of the H criteria are met.

Thus, the proposal failed to demonstrate that the course is not "exclusively the history of ... a field of artistic or professional endeavor," which is an exclusionary criterion on the H Checklist. On the other hand, a number of course competencies suggest that the course may take a broader historical approach to the topic. If true, we recommend that the proposal be revised to show how the course content addresses those competencies and meets the H criteria (especially Criteria 3 & 4).
