Rationale: The class is basically quizzes and discussion board posts. The assignments do not clearly meet Criteria 2. The students may watch films, but we don't see instances when students actually engage in interpretive acts. It really could be that the course does some good interpretive work, but we just can't seem to find it in the syllabus.

HST 306 Debating the Constitution

Rationale: The course certainly reviews historical documents and will situate those documents in their historical context, but the course is mostly history. We don't see much attention paid to philosophies or belief systems. The syllabus and course description really look like a history course more than anything else. The students learn about individual court cases and how it relates to the constitution, but there's not enough for us to see if the course goes beyond just dates and historical facts, rather than critical or philosophical analysis.

# Recommend to Revise & Resubmit for SB designation (mandatory review):

HST 306 American Political Conspiracy

Rationale: This is an interesting course that may meet SB requirements. The fundamental subject of political conspiracies obviously would involve human interactive behaviors. Both the proposal and the syllabus are developed well but do not align well. While the proposal suggests extensive emphasis on SB, the substantive content and "work" requirements in the syllabus do not clearly and explicitly demonstrate this. An institutional perspective appears to dominate the socio-behavioral perspective in the syllabus.
