On the ASU—[SB] Criteria check-sheet, the first criterion, "Course is designed to advance basic understanding and knowledge about human interaction" is checked "no." An SB course should meet ALL of the criteria. If not, a rationale for exclusion should be provided. Also, on this same check-sheet, no documentation was identified (though it was in the second, "explain in detail" section). If these minor issues are addressed the committee will be happy to approve this course.

## G) Global Awareness (Mike Tueller)

**Revise and Resubmit:** 

SOS 100: Introduction to Sustainability

Rationale: This course clearly had a significant cultural focus, and more than half of its material was non-US, so it met the requirements on a basic level. However, the subcommittee felt that the "G" designation was not sufficiently assured by the learning objectives of the course. While those objectives do currently address global culture, they do so in a somewhat auxiliary manner. We would prefer that the learning objectives include language such as: "Understand how sustainability issues affect different cultures around the world, and how culture must be taken into account in designing responses to those issues."

# H) Historical Awareness (April Summitt)

ASM 246 - Human Origins

Rationale: The course description states that this "is a lower-division course that is intended to guide you through an exploration of the scientific evidence for the evolution of humans and our fossil relatives and humankind's place in the natural world." In short, the course looks primarily at hominid evolution (and, to a lesser extent, how paleoanthropologists perform research).

Theories about the evolution of hominid behavior are explored through a comparative analysis of primate behavior (e.g., tool use; social behavior) and an examination of archeological evidence involving species of Homo (e.g., neanderthalensis and sapiens). This, however, isn't what is meant by a "disciplined systematic examination of human institutions as they change over time" (Criterion 3) or an examination of "the relationship among events ideas,

and artifacts [on the one hand] and the broad social, political and economic context [on the other hand]" (Criterion 4).

The required texts and readings focus on physical anthropology and behavioral ecology. The textbook does contain historically situated discussions of ideas about human evolution and group differences, but these are relatively brief.
