 A) Literacy & Critical Inquiry (Barbara Fargotstein) <u>From ASU</u> Approved for L designation, effective fall 2011 (new):

USL 210 Service Learning: Independent Placement

**Rationale**: It is questionable whether this course qualifies for Literacy designation. While there are at least two "reflection" assignments, there don't seem to be any substantial writing assignments (Criterion 3) and the major writing assignment is worth only 16% of the course grade (Criterion 1). This course does provide students with the opportunity to engage in community assessment activities, a worthwhile focus, but as currently written, does not meet the criteria for Literacy designation. If the faculty member is interested in resubmitting for L designation, it would be necessary to redesign written assignments to better meet the criteria.

USL 410 Service Learning: Independent Placement

**Rationale**: The course seems to meet the requirements for C designation; however, the relationship between the required and suggested course readings and the actual readings in the syllabus is unclear. We would like for the authors of the proposal to show how the students are engaged in critical reflection while not in class. For this it would be helpful to have an example of prompts that are given to students to carry out their written reflections. This way we can see how the readings and class discussion inform their service learning experiences and reflections.

## G) Global Awareness (Mike Tueller) <u>From ASU</u> <u>Deny</u>

HST 301: Global History of Health

**Rationale**: While this course is appropriately international, we did not feel that it dealt sufficiently with aspects of global health within the context of various cultures outside the U.S. The focus throughout is on science, government, and global health, rather than on global health within different cultures. While there is a nod to "human practices (migration, environmental alterations, urbanization, slavery, trade, etc.)," we did not find that the course worked toward an improved understanding of what made other cultures different from that of the U.S., or how those different cultures could (or could not) combine their different elements to work together.
