Alison Essary welcomed new and returning members to the council. Dr. Essary discussed the need for a GSC vice chair. Wendy Hultsman offered to serve as vice chair, and council members unanimously approved this appointment.

Humanities, Arts and Design is in need of a third committee member. Brad Ryner agreed to serve on HU until a permanent faculty member can be appointed.

Rationale: SPA 431 meets Criterion 3 and offers "substantial writing assignments that are substantial in depth, quality, and quantity." However, the substantial writing requirements for the course and the way these assignments are scheduled in the syllabus does not meet Criteria 4. The "substantial writing assignments" are not "arranged so that the students will get timely feedback from the instructor on each assignment in time to help them do better on subsequent assignments." Please revise to better address Criteria 4.

Deny for L designation:

SOS 232 Professional Skills in Sustainability

Rationale: The course and its main writing assignments do not seem to sufficiently emphasize "the gathering, interpretation, and evaluation of evidence" with a focus on "analysis of written and spoken evidence" showing "the ability to reason critically and communicate using the medium of language." These written reflections appear to be summary or brief reaction papers and do not constitute substantial writing. While 50% of the grade is based on some form of writing (Criterion 1), the majority of the assignments do not appear to "involve gathering, interpreting, and evaluating evidence" nor "reflect critical inquiry, extending beyond opinion and/or reflection" (Criterion 2). The majority of the writing assignments are framed as "reading reflections" in which the student is prompted to consider his or her proficiencies in "effective and compassionate communication," "collaborative team work," responsive project management," "impactful stakeholder engagement," "caring self-management" and "advanced continuous learning" ("explaining how the skill was acquired, what

purpose it serves, and what to consider when applying the skill in practice"). The Team-Project appears to involve analysis of a sustainability issue pertinent to a project partner but only constitutes 15% of the grade (see p. 6 of the syllabus).

Rationale: The proposal needs to provide more specific evidence of HU criteria, in particular how the course involves critical analysis of a philosophical or religious idea, or relating to human thought.

Although there is some critical analysis of language, it is not enough to warrant the HU. If you look at the learning objectives, only the "Language, Languages, and Linguistics" section really stands out as having content that could warrant the HU. But the Phonetics, Phonology, Morphology, and Syntax sections seem to be more about learning the actual language than anything else. The project proposal and presentation

of final project only really talks about a "topic of interest to research" relating to linguistics, but it isn't clear that this project has to be a critical analysis of a philosophical or religious idea, or relating to human thought. The professor writes that this assignment will enable students to "describe language not based on prejudices or valued judgement of certain dialectics", but it is not clear what this really means, or how the assignment does that.
